## **OLD BUSINESS**

Blazing Paddles: Julianne wrote a tentative agreement between KBPA and Assistance League. The division of funds: \$2000 off the top for the venue, then \$10,000 minus expenses to KBPA and the remainder to go to ALKB/Clothe a Child. Rose requested a change in wording to "after expenses", thus KBPA would keep \$10,000. Discussion ensued. Judy made a motion to accept the agreement as written and Jean seconded. Motion passed. Our contract with Harbor will be Friday pm set-up and Sat, Sun 8am-8pm for registration, events and clean-up. Kathy from PIG will set the player numbers for each event. There will be a food truck in the parking lot. Hats will be included in the registration fee of \$75. Jean will write a check to Harbor for the \$600 deposit towards the \$2000 venue fee.
